

# PERMIT TO ALLOW EMERGENCY USE OF AN AGVET CHEMICAL PRODUCT

## FOR CONTROL OF GRASS BLUE BUTTERFLY IN SOYBEANS

## **PERMIT NUMBER – PER87644**

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows any person to claim that the product can be used in the manner specified in this permit.

## **Products to be used:**

ALTACOR INSECTICIDE [APVMA No. 61824] Plus other REGISTERED PRODUCTS Containing: 350 g/kg CHLORANTRANILIPROLE as their only active constituent.

#### **Directions for Use:**

SOYA BEAN (SOYBEAN)	Grass blue butterfly (Zizina labradus)	70 g product / ha Add non-ionic surfactant at 125 g a.i./100 L

## **Critical Use Comments:**

- Target eggs and hatchlings (neonates or 1st instar) to small larvae.
- Apply a maximum two (2) foliar sprays per season, with 7 14 days between treatments.
- For ground application, apply using calibrated boom sprayer or equivalent equipment using a minimum total water volume of 100 L/ha.
- For aerial application, aircraft must only be applied with aircraft fitted with accurately calibrated equipment, using a minimum total water volume of 30 L/ha with nozzles set to medium spray quality according to ASABE S572 definition for standard nozzles. Refer aerial application and minimising spray drift under *General Instructions* on product label.
- Dangerous to bees. Product should not be applied when bees are actively foraging.

## Withholding Periods:

Harvest: DO NOT harvest for 14 DAYS after application. Grazing: DO NOT graze or cut for stock food for 14 DAYS after application.

## Jurisdiction:

QLD only.

## **Additional Conditions:**

This PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.
