

PERMIT TO ALLOW EMERGENCY USE OF A REGISTERED AGVET CHEMICAL PRODUCT

FOR CONTROL OF LUCERNE SEED WEB MOTH IN LENTILS

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows any person to claim that the product can be used in the manner specified in this permit.

CONDITIONS OF USE

Product to be used: FASTAC DUO INSECTICIDE PLUS OTHER REGISTERED PRODUCTS Containing: 100 g/L ALPHA-CYPERMETHRIN as their only active constituent.

TITAN ALPHA-CYPERMETHRIN 250 SC INSECTICIDE PLUS OTHER REGISTERED PRODUCTS

Containing: 250 g/L ALPHA-CYPERMETHRIN as their only active constituent.

Directions for Use:

Critical Use Comments:

- Apply when infestation reaches an economically damaging level and repeat if necessary.
- Apply a maximum of four (4) sprays per season, with minimum 7 day interval between consecutive treatments.
- Ensure thorough and uniform coverage of all crop foliage.
- Rotate with insecticide products from different mode of action (MoA) chemical groups.

Spray Volume

Use a minimum spray volume of 100 L/ha for ground applications and a minimum 25 L/ha for aerial applications. DO NOT apply with spray droplets smaller than a MEDIUM spray droplet size category according to nozzle manufacturer specifications that refer to the ASAE S572 Standard or the British Crop Production Council guideline.

Withholding Period:

Harvest: DO NOT harvest for 28 DAYS after application. Grazing: DO NOT graze or cut for stock food for 35 DAYS after application.

Jurisdiction:

ALL States and Territories where the use, approved under this permit would otherwise be an offence against an eligible law of the jurisdiction.

Additional Conditions:

This PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the DETAILS and CONDITIONS of this permit.

Exported produce or animals must have appropriate residue tolerance limits established in the importing countries and any residues must not exceed the tolerance limits.
